ELECTRICITY TARIFFS FOR THE PERIOD 01 JULY 2023 - 30 JUNE 2024

Your application dated 12 June 2023 refers.

The Energy Regulator at its meeting held on 2 June 2023 approved the guideline increase of 15,10% for municipalities applicable for 2023/24 financial year. Consequently, the Energy Regulator considered your application for a tariff increase for the period 1 July 2023- 30 June 2024, and in its meeting held on 14 June 2023 approved the tariffs as follows:

1. Domestic Tariffs

1.1 Domestic Pre-Paid Indigent

Tariff blocks	c/kWh
Block 1 (0 - 50)kWh	155,07
Block 2 (51 - 350)kWh	191,19
Block 3 (351 - 600)kWh	270,41
Block 4 (>600)kWh	331,51

2. Commercial Tariffs

2.1. Commercial Convectional

Basic Charge: R 1 568,06 /monthEnergy charge: 240,32 c/kWh

2.2. Commercial Prepaid

• Energy charge: 337,14 c/kWh

3. Industrial Tariff

Basic Charge: R 8 531,57 /month
Energy charge: 152,80 c/kWh
Demand charges: R 339,34 /kVA
